



Below are two **required** documents for you to sign off on in your acceptance form.

1. PARENT/GUARDIAN CONSENT, PERMISSION, AND MEDIA RELEASE

Bay Scholars documents program activities that assist in obtaining funding to support its programs.

I hereby consent to the use of my and my child's name, likeness, and speech in any interview, audio tape, video tape, film, photograph, or other material or collateral made in connection with any Bay Scholars activity for the business or publicity purposes of Bay Scholars, its partners, sponsors, donors, licensees, assignees, affiliates and successors.

I understand that any participation by me or my child offers no remuneration and that my and my child's name, likeness and speech may be edited, produced, recorded for duplication and distribution in any format, medium or through any means of distribution including but not limited to print, digital, electronic, live stream, recording, virtual forms and throughout the United States and abroad.¹

On behalf of myself and my child and our heirs, persona representatives, successors and assigns (the "Releasing Parties"), I hereby expressly release, waive and discharge Bay Scholars, its partners, sponsors, donors, licensees, assignees, affiliates and successors and their respective officers, directors, employees and volunteers from any and all claims and demands that any of the Releasing Parties may have arising out of my and my child's participation in Bay Scholars' program or the broadcast, exhibition, publication, or promotion of the program, now or in the future, including, but not limited to, any claims of invasion of privacy, libel, defamation, infringement of my right of publicity, copyright or trademark infringement, or any other causes of action.

I acknowledge that this general release of liability of Bay Scholars is binding on my heirs, personal representatives, successors, and assigns.

I knowingly waive the benefit of Section 1542 of the California Civil Code, which provides:

"Section 1542. A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which, if known by him, must have materially affected his settlement with the debtor.



I hereby grant permission for Bay Scholars to reproduce and display my name and other biographical information (“**Personal Information**”) in connection with business or publicity purposes of Bay Scholars, its partners, sponsors, donors, licensees, assignees, affiliates, and successors.

In consideration for the Consent, Permission, and Release granted herein, Bay Scholars covenants (i) that it will collect and treat all Personal Information in accordance with applicable privacy laws and Bay Scholars’ privacy policy, available upon request, including de-identifying the Materials if expressly requested.

I understand and agree to the policies stated above. In signing this agreement, I represent and warrant that I am the parent or legal guardian of the minor identified below and that I have the authority to grant the permissions and releases provided above on behalf of myself and my child. I also acknowledge that I have received and agree to abide by the policies and procedures outlined above.

This Consent, Permission and Release is governed by the laws of the State of California.

2. PARENT/GUARDIAN CONSENT TO RELEASE EDUCATIONAL RECORDS

I hereby consent to the release of my student’s education records to Bay Scholars for the purpose of evaluating their Bay Scholars Scholarship application or renewal.
